Pacific Pet Resort shall exercise reasonable care for the pet delivered by the owner. If interactive daycare or group playtime is provided, owner recognizes and accepts potential risks involved in such activity. The owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of Pacific Pet Resort, to include payments of costs for injury to itself or damage to facilities caused by the pet. ()

Owner further agrees to pay all costs and charges for special services requested, all veterinary costs for the pet during the period said pet is in the care of Pacific Pet Resort, and further agrees that the pet shall not leave the facility until all charges due are paid by owner or proper payment arrangements are agreed upon by both parties. ()

Owner gives authorization to Pacific Pet Resort to charge the credit card left on file for any and all services rendered by Pacific Pet Resort as they pertain to the pet's stay. ()
