Owner specifically represents to Pacific Pet Resort that to their knowledge the pet HAS NOT BEEN EXPOSED to any contagious diseases within a thirty-day period prior to check-in. Owner further agrees to maintain required CURRENT VACCINATIONS. ()

If a pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Pacific Pet Resort, in a non-emergency situation, will attempt to contact and inform the owner. If no contact can be made in an emergency situation, Pacific Pet Resort in its sole discretion, may engage the services of a veterinarian, for even, minor sores, chewing, cuts, etc., and thereafter attempt contact. All expenses incurred shall be PAID BY THE OWNER. ()

Pacific Pet Resort shall exercise reasonable care for the pet delivered by the owner. Owner recognizes and accepts potential risks involved in daycare. The owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of Pacific Pet Resort, to include payments of costs for injury to itself, other animals or damage to facilities caused by the pet. **Injuries may include but are not limited to tendon/ligament tears, ACL fractures, lacerations, and punctures.** ()

Owner understands that if the pet is not picked up after the latest pick up time, we will board the pet overnight and any additional charges will apply. Owner agrees to pay all costs and charges for special services requested, all veterinary costs for the pet during the period said pet is in the care of Pacific Pet Resort, and understands that the pet shall not leave the facility until all charges due are paid by owner or proper payment arrangements are agreed upon by both parties. ()

Pet **must be neutered/spayed** in order to attend daycare. Pacific Pet Resort will give **two warnings** due to signs of dominance, aggression, lack of social skills, etc. before expulsion from daycare. On the third warning the pet will be expelled. ()

Owner understands that in order to receive discounted rates for daycare they must purchase a daycare package in full. Owner also understands that daycare packages can only be used **for daycare**. Daycare deposits may not be used towards boarding, grooming, or training. ()

Owner gives authorization to Pacific Pet Resort to charge the credit card left on file for any and all services rendered by Pacific Pet Resort as they pertain to the pet's stay. ()

Owner understands that daycare hours are **Monday through Friday 6:30am to 7pm - Saturday 7am to 5pm - Sunday 7am-5pm. Half days are 6 hours or less from the time of drop off.** ()

California State Law (Civil Code Section 1834.5) states that, IF THE OWNER OF SUCH ANIMAL DOES NOT PICK UP THE ANIMAL WITHIN 14 CALENDAR DAYS AFTER THE DAY THE ANIMAL WAS DUE TO BE PICKED UP, THE ANIMAL SHALL BE DEEMED TO BE ABANDONED at which point the pet will be turned over to the Dept. of Animal Control and will be humanely destroyed.
